Guidelines for submission of Application Forms for admission to LLM and Pharma Programmes/Courses under NRI/NRI Sponsored Quota

Μ.

- 1. **Seat allocation**: Application under NRI/NRI Sponsored quota can be made for admission to all programmes/courses against 10% quota of the intake capacity of a particular Programme/Course. These seats shall be over and above the intake.
- 2. Categories of NRI: The University shall fill the 10% quota of NRI candidates in the following manner:
 - a. Category 1: Preference shall be given to the NRI or blood relations of the NRI's i.e., son/daughter/real brother/real sister of NRIs for admission against available vacancies. The NRI's MUST submit an NRI certificate obtained from Indian Diplomatic Mission/Chancellery/High Commission under their seal; whereas blood relations MUST submit sufficient documents clarifying without ambiguity their true relationship with the NRI to the satisfaction of the University.
 - b. Category 2: If seats remain vacant, candidates sponsored by an NRI shall be granted admission against vacancies. The candidate MUST submit the documents as annexed to these guidelines as per instructions.
 - 3. Academic Eligibility: Marks Eligibility for admission under NRI shall be the same as that for Open Merit candidates *i.e.*, marks %age of the qualifying examination shall be the same as that for General category without any consideration of the reserved category. The candidates should have passed the qualifying examination in full without any backlogs.
 - 4. Subject Eligibility: Subject combination eligibility of the candidates regarding qualifying examination for a programme shall be the same as for general candidates.
 - Candidates seeking admission in more than one programme/course under NRI quota must fill separate application forms for each programme/course.
 - 5. Important dates:
 - On-line submission and last date for Application Form including deposition of application fee of Rs. 550/- (per programmes) is from 19-09-2025 to 29-09-2025.

- **6. Mode of applying**: Candidates interested in seeking admission under these categories are advised to follow the below steps for filling of On-Line Application Form.
 - Step-1: Visit http://www.kashmiruniversity.net or www.kashmiruniversity.ac.in and click on Link Admissions. Read Important Instructions for Registration and Submission of Form carefully before proceeding further.
 - Step-2: Candidate needs to register himself/herself before submitting the Online Application Form. For Registration with the System Click on the <u>"Register as Student"</u>. Remember, the Username and Password for future reference.
 - Step-3: After successful Registration, login into the system for submitting On-line Application Form. Enter your "Registration No." and Click "Next".
 - Step-4: Enter the required details and Upload your latest passport size Photograph and click "Next".
 - Step-5: Select the desired Preferences (After last date the Preference of Campus/College selected will not be updated/changed). Click "Next".
 - Step-6: If there is any variation click on <u>"Previous"</u> button, make necessary corrections and then Click <u>"Submit"</u>. Get a printout of the Form and note the Form No. for future reference.
 - Step-7: Deposit the non-refundable "Application Fee of Rs. 550/- for one Programme and Rs. 550/- for each subsequent Programmes, through Online mode only.
 - Step-8: Applicant can view the Application details by providing username and password. Applicant is required to make sure that "Application Status" on application form is "Fee Received" after 3 days otherwise application will be treated as incomplete and summarily rejected.
 - Step-9: Candidates in their own interest are advised to apply & submit application promptly and not to wait till the last date/time for applying online. Directorate shall not be responsible if candidates are not able to submit their applications on account of the last-minute rush. Please retain print-out of application form for future references.
- 7. **Documents to be uploaded**: The candidates are required to upload the following documents alongwith the application form. The originals shall have to be shown at the time of admission:
 - a. Marks Sheet/Transcript of the qualifying examination;
 - b. Proof of claimed category (NRI/relationship certificates/sponsorship certificate);
 - c. Annexures-A;
 - d. Annexure-B for NRI sponsored candidates only;
- 8. Uploading of list of Eligible Candidates: The list of the applicants shall be uploaded on the official website of the University for any Queries, which shall be entertained upto one day after uploading the list. Revised list, if required, shall be uploaded and then selection list shall be processed.

- 9. **Mode of Selection**: The candidates shall be selected on the basis of qualifying examination; however, if the number of candidates is more than intake, then qualifying examination merit shall be considered for preparing selection lists.
- 10. Resolution of tie: Where two or more candidates have secured equal marks in the qualifying examination for admission to a particular programme, the tie shall be decided as under:
 - a) the aggregate merit of the subject in which the admission is sought shall be reckoned by taking the merit of that subject in all the three years BA/B.Sc./B.Com, 1st year, 2nd year and 3rd year or all 6 semesters into account;
 - c) In case the problem still remains unresolved or the candidate seeks admission to a Programme where the discipline in which he/she seeks admission is not taught at undergraduate level, then candidate with higher academic merit in the preceding examination i.e., merit in Hr. Sec. Part-II (10+2) where the minimum qualification is graduation and merit in Matric (10th) where the minimum qualification for admission is 10+2 shall be given preference.
 - d) If still tie persists then candidate older in age shall be given preference.
- 11. **Web address**: In their own interest, candidates are advised to remain in touch with the official website of the University of Kashmir *i.e.*, www.kashmiruniversity.ac.in or www.kashmiruniversity.net. The notices placed on the website shall be treated as served to the candidates.
- **12. NRI Candidates**: Whereas an applicant himself/herself is an NRI or Children/Wards of NRI and family originally belongs to the UT of J&K. Further, the documents required for NRI Candidates shall be as under:
 - (i) Marks Card of the qualifying Examination;
 - (ii) NRI certificate issued by the Ministry of External Affairs, Government of India or Indian Embassy Overseas under Ministry of External Affairs with holding of Indian Passport (for NRI) or Pedigree Table/Family Tree establishing relationship of the candidate with the NRI along with documentary Proof (Blood relations of NRI);
 - (iii) Copy of NRI Bank Account preferably in the country where the candidate is residing or of NRI Account in India;
 - (iv) Copy of Indian Passport;
 - (v) PAN Card, if any of the candidate/parents;
 - (vi) Domicile Certificate of the candidate.
 - (vii) Any other document as may be required by the University for its satisfaction.
- 13. NRI Sponsored Category: NRI sponsored candidates shall be of the candidates who are being sponsored by an NRI. Further, the documents required for NRI Sponsored Candidates shall be as under:
 - (i) Marks Card of the qualifying Examination;
 - (ii) NRI Sponsorship Letter;

- (iii) Undertaking of NRI duly attested by the legal authority of that country where sponsor is residing or Indian Embassy Overseas;
- (iv) Resident/National Certificate or NRI certificate of the sponsor;
- (v) Affidavit by the sponsor to the effect that he will sponsor the candidate for full Programme/Course;
- (vi) Employment certificate of the sponsor;
- (vii) PAN Card of the sponsor;
- (viii) Domicile Certificate of the candidate.

14. Notes:

- a. The seats shall be filled up purely on the basis of Eligibility of the candidates, without any consideration of reserved category (ies).
- b. Only such candidates shall be eligible, who have registered themselves.
- c. Only Domiciles of UT of J&K are eligible to compete against the above seats of NRI or NRI Sponsored.
- d. The eligibility under NRI/ NRI Sponsored shall be subject to such other conditions as may be notified by the University.
- e. Mere submission of the documents does not confer any right of the candidate for admission unless and until the eligibility is verified by the University.
- 15. Fee for NRI / NRI Sponsored Candidates: The fee for the candidate's seeking admission under NRI/NRI Sponsored Quota shall be double the amount as charged for Self Finance Candidates of each programme/course in addition to normal dues. The amount shall be paid in the same way as self finance quota *i.e.*, 50% at the time of admission, 25% in 3rd semester and 25% in 4th semester (for 2 year programmes); however, for 4 or more than 4 year programmes it shall be four equal installments at the time of admission to odd semesters i.e., 25% each at the time of admission to 1st, 3rd, 5th & 7th semesters during 1st four years.
