### b) 3-Year LL.B. Programme

#### II) Important Notes:

- A. Candidates who have qualified 3-year Graduation are eligible for **2-year Masters Programmes**; whereas, candidates who have qualified 4-year Graduation (Honours Or Research Mode) are eligible for **1-year Masters Programmes**; however, if a 4-year Graduate wishes to apply for 2-year Masters programme, he/she is eligible.
- B. **For 2-year Masters Programmes**, candidates having acquired minimum of 12 credits during 3-year graduation in a particular subject under NEP-2020 or CBCS or having studied a particular subject for all 3 years during Annual scheme or in all the 6 semesters in Semester scheme are eligible; however, in programmes having open eligibility, all graduates are eligible.
- C. **For 1-year Masters Programmes**, candidates having acquired **20 credits** in a particular subject are eligible in that particular subject only.

### III) Mode of Selection:

Selection of candidates for general and self-finance seats is based on positive score obtained in Kashmir University Entrance Test (KUET); whereas, for Foreign Nationals and NRI/NRI Sponsored seats, admission is granted on the basis of merit of qualifying examination. The Entrance Test Syllabii and Previous Years Question Papers for all programmes are available on the official website of the University of Kashmir under the “**Admissions**” tab.

### IV) Eligibility:

**a) Non-Provisional Candidates:** Candidates who have passed their qualifying examination (Graduation – Annual Scheme, Semester Scheme, CBCS Or NEP-2020) are eligible for admission to the above Masters and LLB Programmes and they shall submit their forms under non-provisional category (Candidates who have qualified Graduation).

**b) Provisional Candidates:** Provisional Candidates: Candidates **(i)** whose result is awaited or **(ii)** who are appearing or **(iii)** who shall be appearing in the qualifying examination (Graduation) can apply provisionally under **provisional category**, on their own risk and responsibility, subject to **fulfilling all eligibility conditions**, including passing of Graduation in full, and acquiring minimum required percentage of marks by or before **28th July, 2026**. Please note that any candidate, **failing to upload online the required details of eligibility**, shall forfeit the right to admission even if having (i) available the eligibility documents or (ii) having appeared in the entrance test or (iii) even if having higher merit than those selected.

**Important Note:** Any candidate who wants any modification in the application form or have any query related to application form can post their queries online from the dashboard after logging into their account by entering their username and password. Detailed eligibility criteria for the Masters and LL.B. offered by the University are mentioned in the Prospectus-2026 available on the University Website [www.kashmiruniversity.net](http://www.kashmiruniversity.net) or [www.uok.edu.in](http://www.uok.edu.in) under the **Admissions tab**.

V) **Important dates for submitting on-line application & deposition of fee: Last date for submission of On-line Application Forms along-with deposition of requisite application fee is from 02-06-2026 to 30-06-2026. The notified dates are final and no extension shall be granted.**

### VI) Submission of On-Line Application Forms:

The candidates are advised to follow the below steps for filling of On-Line Application Forms.

**Step-1:** Visit <http://www.kashmiruniversity.net> or [www.uok.edu.in](http://www.uok.edu.in) and click on Link **Admissions**. Read carefully Important Instructions for Registration and Submission of Form, before proceeding further.

**Step-2:** Candidate needs to compulsorily register himself/herself before submitting the Online Application Form. For Registration with the System Click on the “**Register as Student**”. Remember for future reference, the Username and Password which you create during registration process.

**Step-3:** After successful Registration, login into the system for submitting On-line Application Form. Enter your **"Qualifying Examination Registration No."** and Click **"Search"**. You will either get pre-filled information or you need to enter manually the required detail.

**Step-4:** Enter the required details under **"Personal Details, Qualifying Examination Details, Additional Details (if any)"**.

**Under Qualifying exam section, in case you have passed your qualifying graduation under NEP-2020, you need to select the following:**

- a) **3-Year Graduates:** Select **TYUP**. Choose subject in which you have minimum of **12 credits** in that particular subject.
- b) **4-Year Graduates:** Select **FYUP**. Choose the subject in which you have minimum of **12 credits** in that particular subject.

and click **"Save and Move Next"**.

**Step-5:** Mention the credits of each subject given in the previous step and Click **"Save and Move Next"**.

**Step-6:** Select the desired Preferences, (wherever required) [After last date the Preference of Campus/College selected will not be updated/changed]. Click **"Save and Move Next"**.

**Step-7:** If there is any variation click on **"Previous"** button, make necessary corrections and then upload the latest passport size photograph, specimen signature, marks certificates and other related documents in relevant rows. Click **"Save and Submit"**.

**Step-7:** Deposit the non-refundable Online **fee of Rs. 900/-** for one Programme plus **Rs. 250/-** for **each subsequent Programmes**, chosen through the same application. Please note that you can include multiple programmes you are interested in seeking admission through a single online application. Get a printout of the Form and note the Form No. for future reference.

**Step-8:** Applicants can view the Application details at any point of time by providing username and password. An applicant is required to make sure that **"Application Status"** on application form is **"Fee Received"** after 3 days otherwise application will be treated as incomplete and summarily rejected. Under such conditions, candidates can post a query through online mode only and wait for response.

**Step-9:** Candidates in their own interest are advised to apply & submit application promptly and not to wait till the last date/time for applying online. Directorate shall not be responsible if candidates are not able to submit their applications on account of the last-minute rush.

## **VII) Hard Copy of Application Form and Fee Receipt:**

A Candidate need not to submit the hard copy of the Application Form nor of fee receipt; however, they must take printout of the online submitted Application Form and Fee Receipt and retain it for future reference.

### VIII) **Mandatory Document uploading:**

A candidate has to compulsorily upload photograph, specimen signature, marks card and reserved category certificate (if applying under any reserved category) under relevant rows. Uploading an item, in any irrelevant row, shall not be considered and the candidate shall be responsible for all consequences. For OSJ category (**candidates residing outside the jurisdiction of Kashmir Division and having studied from Institutions outside Kashmir Division**), uploading of domicile proof is mandatory under reserved category certificate row.

### IX) **Disclaimer:**

Directorate will not check/verify the educational details/category certificates etc. of the candidates at the time of Online submission of application form for appearing in the entrance test and it will be the sole responsibility of a candidate to ascertain that he/she fulfills all the eligibility criteria for admission to the programme he/she is applying for. However, the documents will be verified by the concerned Department/ Centre/ Campus/ College at the time of completion of admission related formalities in respect of the provisionally selected candidates to a particular programme. The admission of a provisionally selected candidate will be rejected at any time if it is found that the applicant was not fulfilling the eligibility criteria by the date fixed for the purpose *i.e.*, **28<sup>th</sup> July, 2026** or has misrepresented/concealed any facts/information.

### X) **Other relevant information:**

- a) **Application Form/Fee Reconciliation Status:** The candidates must check the status of their Application Forms after three days of its online submission. In case, the status of Application is not updated to **“Fee Received”** or **“Fee Reconciliation is pending”**, a candidate should post a query online from the dashboard and if a query does not get resolved, a candidate may contact the **IT Cell (adjacent to DSW Office Near Moulana Rumi Gate, University of Kashmir)**, alongwith Application Form, Fee receipt and all other documents, by or before **30-06-2026**; thereafter, no claim, whatsoever, will be entertained by the University;
- b) **Submission of Application Forms and appearance in the Entrance Test is subject to determination of eligibility for admission to the Programme by reference to the Admission Policy-2026;**
- c) The detailed **Date Sheet** for conduct of Entrance Test shall be uploaded on the University website in due course of time; however, the dates of **Entrance Test shall be conducted from 15<sup>th</sup> to 26<sup>th</sup> July, 2026;**
- d) **Notification for Self-financed Seats shall be issued on 02-08-2026;** however, only those candidates shall be eligible for admission under Self-financed Seats Category, who have appeared in the Entrance Test of the concerned subject and have applied online on time.
- e) **Notification for NRI and NRI Sponsored seats shall be issued on 27-07-2026;** therefore, candidates interested in applying under the category shall keep relevant documents available (NRI Certificate/ NRI Sponsorship letter; NRI Bank Account Details; Passport, Employer certificate for NRI sponsored candidates). The selection of the candidates under said quota shall be made purely on the basis of marks obtained in the qualifying examination.
- f) For any further query/ information, the candidates shall contact the **respective Admission Coordinators mentioned in the Prospectus-2026 available on University website.**
