1-Year Masters Programme in Computer Applications (Lateral Entry Mode) (Session-2026)

On-Line Applications are invited from eligible candidates for admission to **1-Year Masters Programme in Computer Science through Lateral Entry to 3rd Semester** for the session-2026 offered at following Campuses/Colleges:-

- **Main Campus, University of Kashmir (5 Seats);**
- **North Campus, Baramulla (5 Seats);**
- **South Campus, Anantnag (5 Seats);**
- **Government Degree College, Baramulla (5 Seats);**
- **SSM College, Parihaspora, Pattan (5 Seats);**
- **IITM College, Hyderpora, Srinagar (5 Seats);**

I) Eligibility:

Candidates possessing a Four-Year Bachelors Degree in B.E/B.Tech (Computer Science Engineering/Information Technology) **OR** Four Year BCA Programme from any recognized University/Institution.

II) Intake:

Five seats shall be allotted to each campus/college strictly on the basis of merit obtained in the Kashmir University entrance test and campus/college preference.

III) Selection Procedure:

Admission shall be made on the basis of a Common Entrance Test to be conducted by the University, wherever the number of eligible applicants exceeds the number of available seats.

IV) Important dates:

On-line submission and last date for Application Forms from 15-09-2026 to 25-09-2026. The notified dates are final and no extension shall be granted.

V) Submission of On-Line Application Forms:

The candidates are advised to follow the below steps for filling of On-Line Application Forms.

Step-1: Visit <http://www.kashmiruniversity.net> or www.kashmiruniversity.ac.in and click on Link **Admissions**. Read Important Instructions for Registration and Submission of Form carefully before proceeding further.

Step-2: Candidate needs to register himself/herself before submitting the Online Application Form. For Registration with the System Click on the **"Register as Student"**. Remember, the Username and Password for future reference.

Step-3: After successful Registration, login into the system for submitting On-line Application Form.

Step-4: Enter the required details and Upload your latest passport size Photograph and click "Next".

Step-5: Select the desired Preferences, (wherever required) [After last date the Preference of Campus/College selected will not be updated/changed]. Click "Next".

Step-6: If there is any variation click on "Previous" button, make necessary corrections and then Click "Submit".

Step-7: Deposit the non-refundable Online fee of Rs. 900/- for each subsequent Programmes, chosen through the same application. Get a printout of the Form and note the Form No. for future reference.

Step-8: Applicant can view the Application details by providing username and password. Applicant is required to make sure that "**Application Status**" on application form is "**Fee Received**" after 3 days otherwise application will be treated as incomplete and summarily rejected. Under such conditions, candidates can post a query through online mode only

Step-9: Candidates in their own interest are advised to apply & submit application promptly and not to wait till the last date/time for applying online. Directorate shall not be responsible if candidates are not able to submit their applications on account of the last-minute rush.

VI) Hard Copy of Application Form and fee receipt:

A Candidate need not submit the hard copy of the Application Form nor of fee receipt; however, they must take printout of the online submitted Application Form and fee receipt and retain it for future reference.

VII) Disclaimer:

Directorate will not check/verify the educational/category certificates etc. of the candidates at the time of Online submission of application form for appearing in the written examination and it will be the sole responsibility of the candidate to ascertain that he fulfills all the eligibility criteria for admission to the programme he/she is applying for. However, the documents will be verified by the concerned Department at the time of completion of admission related formalities in respect of the provisionally selected candidates to a particular programme. The admission of a provisionally selected candidate will be rejected at any time if it is found that the applicant was not fulfilling the eligibility criteria on the date fixed for the purpose or has misrepresented/concealed any facts/information;

VIII) Other relevant information:

- **Application Form/Fee Reconciliation Status:**

The candidates must check the status of their Application Forms after three days of its online submission. In case, the status of Application is not updated to "Fee Received" or "Fee Reconciliation is pending", a candidate should post a query online from the dashboard and if a query does not get resolved, a candidate may contact the **IT Cell adjacent to DSW Office Near Rumi Gate, University of Kashmir**, alongwith Application Form, Fee receipt and all other documents, within one day after the last date of submission of Application Form i.e. upto **26-09-2026**; thereafter, no claim, whatsoever, will be entertained by the University;

- Submission of Application Forms and appearance in the Entrance Test is subject to determination of eligibility for admission to the Programme by reference to the Admission Policy-2026;
- The date for conduct of Entrance Test shall be notified separately and notice in this regard will be uploaded on the official website of University www.kashmiruniversity.net or www.uok.edu.in ;
