On-Line Applications are invited from eligible candidates for admission to 2-Years LL.M Programme for the academic session 2021 at Main Campus, University of Kashmir. Admission to the programme shall be governed by the Admission policy available on University website and relevant statutes governing the programme.

i) Important dates:

Issuance of On-Line Application Forms	06-12-2021
Last date of submission of On-Line Application Forms and deposition of Entrance Test Fee	13-12-2021

ii) Eligibility:

Candidates should have passed L.L.B (Professional) or B.A-LL.B (5-Years) from the University of Kashmir or from any other University/Institute recognized by UGC with at least 55% marks for Open Merit and 50% marks for reserved categories.

iii) Admission Criteria:

The eligible candidates shall have to appear in the Entrance Test at their own expenses at the University specified centres for which date shall be notified separately.

iv) Submission of On-Line Application Form:

Step-1: Visit http://www.kashmiruniversity.net or www.kashmiruniversity.ac.in and click on Link Admissions 2019. Read Important Instructions for Registration and Submission of Form carefully before proceeding further.

Step-2: Enter your "Registration No." and Click "Next".

Step-3: Enter the required details and Upload your latest passport size Photograph and click "Next".

Step-4: If there is any variation click on <u>"Previous"</u> button, make necessary corrections and then Click <u>"Submit"</u>. Get a printout of the Form and note the Form No. for future reference.

Step-6: Deposit the non-refundable "Application Fee of Rs. 250/- (including Rs. 150/- as IT Fee) and Entrance Test fee of Rs. 500/- "through Online mode only.

v) Forms (Hard copy):

Only those of the candidates who apply under any **Reserved Category** are required to submit downloaded Application Form (hard copy) with the following documents in the **Department of Law, University of Kashmir, Hazratbal** and obtain a receipt for record.
