The candidates whose particulars are given in the selection lists appended to this notification have been selected provisionally for admission to **B. Ed programme** session 2024 – 26 purely on the basis of merit obtained by them at UG / PG level.

### **Important Note:-**

The Head Deptt. of Education Main Campus / Coordinator Deptt. of Education, South Campus, University of Kashmir shall ensure that all the selected candidates possess the minimum required eligibility and have passed their qualifying examination/ have category certificate (if selected under any reserved category) issued by or before 31<sup>st</sup> Oct, 2024. The same may be verified by the original documents/certificates of the candidates. No authority slip shall be issued by the Head Deptt. of Education Main / South Campus to the candidates who aren't eligible or does not have the valid category certificate.

The admission of the candidates is subject to the:-

1. Production of all relevant original documents {Marks Card/s of qualifying examination, Provisional and Character certificates of the Institution last attended, valid Reserve Category Certificate (wherever applicable), Migration Certificate};
2. Production of eligibility-cum-revival of registration/migration form wherever applicable alongwith prescribed fee;
3. Fulfilling of minimum required eligibility conditions to be verified by the concerned Deptt;
4. Clearance from the Academic Section in respect of the candidates having qualified examination from Universities/Institutions other than University of Kashmir;
5. NOC from the concerned Department in case of in-service candidates;
6. Production of an affidavit sworn in before I<sup>st</sup> Class Magistrate stating that:
  - I am not on rolls of any other Institution;
  - All the submitted certificates/documents are genuine;
  - I have not availed the benefit of the reserved category certificate for pursuing any UG Programme earlier (if seeking admission under Reserved Category);
  - I will strictly adhere to the rules and regulations of the University;
  - I understand that in case of any misinformation or concealment of any information or indiscipline, my admission to the programme shall be cancelled and I shall be subjected to legal action;
  - I submit this affidavit under free will and without any pressure, compulsion, fraud or coercion.
7. The provisionally selected candidates are advised to minutely go through the instructions before the submission of Admission Form etc available on the official website [www.kashmiruniversity.net](http://www.kashmiruniversity.net). The selected candidates are hereby directed to complete the admission formalities from **20<sup>th</sup> Nov, 2024 to 30<sup>th</sup> Nov, 2024**. However, before depositing the required admission fee, the candidates shall have to approach alongwith all documents / certificates in original to the respective departments for verification of the documents / certificates for obtaining authority form the concerned Head / coordinator for deposition of the admission fee. Any provisionally selected candidate failing to complete the admission formalities upto **30<sup>th</sup> Nov, 2024** shall forfeit his / her right to admission and the resultant vacancy (ies), if any, shall be filled up from among the waiting list candidates.
