## IV. OTHER TERMS AND CONDITIONS:

- 1. Reservation to above posts is as per the provision of S.O 305 dated 21.05.2024 issued by the Govt of UT Jammu & Kashmir.
- 2. Only those candidates should apply for the post, who fulfil all the eligibility conditions by the last date of submission of Application Form;
- 3. Application form found incomplete in any respect shall be rejected without any Notice;
- 4. Application of Government servants should be sent through the Administrative Authority concerned, University Employees through the Registrar of their respective Universities. Application forms not routed through the respective channels are liable to be rejected. However, such candidates may submit online Application form along with the requisite enclosures and application fee (whichever applicable) before the last date of submission of application form;
- 5. Candidates who have successfully submitted their online application form have to ensure that their name appears in the list which would be available on the University website in due course of time.
