# ADMISSION NOTIFICATION No. 04 (A) of 2025 Bachelors in Visual Arts (BVA) and Bachelors in Preforming Arts (BPA) (Session-2025)

Consequent upon the availability of seats, fresh on-line Applications are invited from the eligible candidates for admission to BVA and BPA programmes offered at Main Campus, University of Kashmir for the academic session 2025.

#### I) Eligibility:

#### a) Bachelors in Visual Arts (Applied Art, Painting, Sculpture)

The candidates as would have passed their 10+2 examination from Board of School Education or any other recognized Board shall be eligible for admission to the Course. However, selection shall be made on the basis of merit obtained at the qualifying examination.

## b) Bachelors in Preforming Arts (Vocal-India Classical, Tabla Indian Classical, Sitar Indian Classical, Santoor Indian Classical, Santoor Sufiyana)

The candidates as would have passed their 10+2 examination from Board of School Education or any other recognized Board shall be eligible for admission to the Course. However, selection shall be made by the Admission Committee consisting of the Principal of the constituent/affiliated college and heads of the departments. However, equal weightage shall be given to the percentage of marks obtained by the candidate in the qualifying 10+2 examination and his/her performance in the aptitude test.

The aptitude test shall be as follows:

- Swar-Ability to identify Shudha and Vikrit notes and to sing or play them 10marks:
- Laya-Knowledge of simple Laya and the following Talas: Teenal, Kaharwa, Dadra 10 marks;
- Raga-Ability to sing composition in an raga: 10 marks;
- General Knowledge Test (Written Test having subjective and objective questions related to Music) 10Marks;
- Viva-Voce

Detailed eligibility criteria for the above courses offered by the University are mentioned in the Prospectus-2025 available on the University Website **www.kashmiruniversity.net** under the link **Admissions.** 

#### II) Selection Procedure:

Percentage of marks obtained by the candidates in qualifying examination 10+2 and his/her performance in the aptitude test;

#### III) Important dates

- On-line submission and last date for Application Forms including deposition of fee is from 25-06-2025 to 28-06-2025
- All dates notified are final and extension shall not be granted under any circumstances.

#### IV) Submission of On-Line Application Forms:

The candidates are advised to follow the below steps for filling of On-Line Application Forms.

- **Step-1:** Visit http://www.kashmiruniversity.net or www.kashmiruniversity.ac.in and click on Link Admissions. Read Important Instructions for Registration and Submission of Form carefully before proceeding further.
- **Step-2:** Candidate needs to register himself/herself before submitting the Online Application Form. For Registration with the System Click on the <u>"Register as Student"</u>. Remember, the Username and Password for future reference.
- **Step-3:** After successful Registration, login into the system for submitting On-line Application Form. Enter your "Registration No." and Click "Next".
- **Step-4:** Enter the required details and Upload your latest passport size Photograph and click "Next".
- **Step-5:** Select the desired Preferences (After last date the Preference of Campus/College selected will not be updated/changed). Click "Next".
- **Step-6:** If there is any variation click on <u>"Previous"</u> button, make necessary corrections and then Click <u>"Submit"</u>. Get a printout of the Form and note the Form No. for future reference.
- Step-7: Deposit the non-refundable "Application Fee of Rs. 300/- (including Rs. 50/- as IT Fee) and Processing fee of Rs. 250/-" i.e. Rs. 550 and Rs. 250/- for each subsequent Programmes, through Online mode only.
- **Step-8:** Applicant can view the Application details by providing username and password. Applicant is required to make sure that "**Application Status**" on application form is "**Fee Received**" after 3 days otherwise application will be treated as incomplete and summarily rejected.
- **Step-9:** Candidates in their own interest are advised to apply & submit application promptly and not to wait till the last date/time for applying online. Directorate shall not be responsible if candidates are not able to submit their applications on account of the last-minute rush. Please retain print-out of application form for future references.

#### V) Hard Copies of Application Forms and fee receipt:

Candidates need not to submit hard copy of the Application Form nor fee receipt; however, they must take printout of the online submitted Application Form and fee receipt and retain it for future reference.

#### VI) Disclaimer:

Directorate will not check/verify the educational/category certificates etc. of the candidates at the time of Online submission of application form for appearing in the written examination and it will be the sole responsibility of the candidate to ascertain that he fulfills all the eligibility criteria for admission to the programme he/she is applying for. However, the documents will be verified by the

concerned Department at the time of completion of admission related formalities in respect of the selected candidates to a particular programme. The admission of the selected candidate will be rejected at any time if it is found that the applicant does not fulfill the eligibility criteria or has misrepresented/concealed any facts/information;

#### VII) Other relevant information:

#### • Application Form/Fee Reconciliation Status:

The candidates must check the status of their Application Forms after three days of its online submission. In case, the status of Application is not updated to <u>"Fee Received"</u> or <u>"Fee Received"</u> or <u>"Fee Received"</u>, the candidate should contact the IT Cell adjacent to DSW Office Near Rumi Gate, University of Kashmir, alongwith Application Form, Fee receipt and all other documents, within two days after the last date of submission of Application Form i.e. upto 30-06-2025; thereafter, no claim, whatsoever, will be entertained by the University;

- Submission of Application Forms is subject to determination of eligibility for admission to the Programmes by referring to the Admission Policy-2025;
