### Terms and conditions for auction of obsolete/unserviceable steel lockers and racks

- 1. Bids must be offered separately against each category of item on per item basis.
- 2. Bids reaching beyond the cut-off time shall not be considered.
- 3. For participation in the process, the interested bidders shall have to deposit Rs. 5000/- in cash as security deposit in the Estates section under proper receipt on 11-03-2020 i.e. before opening of bids which shall be refunded to the unsuccessful bidders once auction process is completed. However, for successful bidder, the same shall be adjusted against the bid amount.
- 4. Incomplete/ anonymous bids or Bids quoting amount less than the minimum reserve bid shall be rejected without notice.
- 5. The University reserves the right to accept or reject any bid without assigning any reason.

- 7. The successful bidder/s shall to deposit the full amount before lifting of items.
